# **NOTES FROM THE EMC**

What a year 2021 has been... oh, wait, it's only February! Since we last spoke in December, we've had record snowfall, flooding, and ice storms, all while approaching the one (1) year "anniversary" of the COVID-19 pandemic.

Here is a brief recap of the Lycoming County EMA Office's work over the past 3 months:

- In the fall newsletter, we briefly touched on the drought conditions in Lycoming County. Well, one week in December took care of that... and led to the Christmas Eve/Day Flooding across most of the county. A huge "Thank You" to all of the EMCs that sent reports, gauge readings, and photos into the EMA office/EOC throughout the event. Unfortunately, due to the previous drought conditions, our office was unaware of some issues with the County's Automated Stream Gauge system. We have been able to correct most of the issues, but others will not be able to be fixed until the weather turns warmer. We are also looking into some improvements and enhancements to the system in 2021.
- COVID-19 still continues to be on the forefront of everyone's minds. DPS in conjunction with the PA Dept. of Health has established a Community Based Testing Site in Lycoming County. This testing will be held at the Old Lycoming Township Fire Department from 3/1/2021 through 3/3/2021. More information will be available on our website & social media pages as it becomes available.
- Pennsylvania is currently in Phase 1A of their vaccine distribution plan. Those eligible for vaccination during this phase include: health care personnel (including EMS personnel), long term care facility residents, any persons ages 65 and over, or persons 16-64 with high-risk conditions. As we begin to plan out for Phases 1B, 1C, and 2, we will be looking at locations to hold larger vaccination clinics and the County EMA office may ask for your assistance.
- Reminder... please be checking your municipal EOPs & NARMS and making any necessary updates. Any updates should be submitted to the County EMA office. And, training is still available! Most classes towards PEMA certification (Basic, Advanced, and Professional) are being held virtually at this time. Utilize the TrainPA website to find these offerings.

# **DO A DIGITAL DECLUTTER THIS SPRING**

A few easy, actionable tips will help you stay cyber safe and protect your personal data and identity. <u>The National Cyber Security Alliance</u> (NCSA) and <u>Better Business Bureau</u> (BBB) are encouraging all consumers freshen up their online lives by conducting a thorough cleaning of their cyber clutter. With preventing identity theft a top safety concern for Americans, NCSA and BBB encourage everyone to make "digital spring cleaning" an annual ritual to help protect valuable personal data.

Refreshing your online life is a relatively simple process. NCSA and BBB have identified the top trouble-free tips everyone should follow this spring and all year round.



#### KEEP A CLEAN MACHINE

Ensure all software on internet-connected devices – including PCs, smartphones and tablets – is up to date to reduce risk of infection from malware.

#### LOCK DOWN YOUR LOGIN

Your usernames and passphrase are not enough to protect key accounts like email, banking and social media. Begin your spring cleaning by fortifying your online accounts and enabling the strongest authentication tools available, such as biometrics, security keys or a unique one-time code through an app on your mobile device.



#### DECLUTTER YOUR MOBILE LIFE

Most of us have apps we no longer use and some that need updating. Delete unused apps and keep others current, including the operating system on your mobile devices.



#### DO A DIGITAL FILE PURGE

Perform a good, thorough review of your online files. Tend to digital records, PCs, phones and any device with storage just as you do for paper files. Get started by doing the following:

- Clean up your email: Save only those emails you really need and unsubscribe to email you no longer need/want to receive.
- Back it up: Copy important data to a secure cloud site or another computer/drive where it can be safely stored. Passphrase protect backup drives. Always back up your files before getting rid of a device, too.



#### OWN YOUR ONLINE PRESENCE

Review the privacy and security settings on websites you use to ensure they're at your comfort level for sharing, It's OK to limit how and with whom you share information.

# Wireless Emergency Alerts (WEA)

#### What are Wireless Emergency Alerts?

- Wireless Emergency Alerts, or WEAs, are free messages sent directly to your cellular phone, warning you
  about severe weather, AMBER Alerts and threats to safety in your area.
- WEAs are sent to you by your state and local public safety officials, the National Weather Service, the National Center for Missing and Exploited Children, the U.S. Geological Survey, and the President.
- WEAs began in 2012 and should already be on your cellular phone or other wireless device.
- WEAs are no more than 360 characters and will provide brief critical information about a threat in your location or an AMBER emergency.
- The WEA notification is designed to get your attention and alert you with a unique sound and vibration.
- WEAs resemble a text message on your cellular phone but WEAs will not interrupt calls in progress.
- WEA messages allow alerts to be sent to cellular phones in a geographically targeted affected area.
- WEAs are one-way alerts to any cell phones in range of the cell tower, which ensures that authorities cannot collect any data from an individual.
- WEAs are not affected by network congestion.
- Wireless customers will not be charged for the delivery of WEA messages.

#### Unique Sound & Vibration

- The unique sound and vibration (Common Audio Attention Signal and Vibration Pattern) you receive when a WEA is sent are prescribed in Part 10 of the Code of Federal Regulations for use in Alert messaging only.
- The unique sound and vibration cadence are particularly helpful to people with visual or hearing disabilities.

#### Will I Receive WEAs on My Cell Phone?

- To find out if your phone can receive WEA alerts, contact your wireless provider. All the major providers
  participate in WEA on a voluntary basis. It will take time for upgrades in infrastructure, coverage and handset
  technology to allow WEA enhancements to reach all cellular customers.
- Wireless providers are selling devices with WEA capability included but not all handsets now on the market can receive WEAs. To learn how yours is configured, contact your wireless provider or phone manufacturer.
- WEA messages can save lives. Do not ignore these messages! WEAs contain basic information so if you
  receive a WEA, seek additional information from other sources such as radio or TV.

IPAWS is a national system for local alerting that provides authenticated emergency alert and information messaging to the public through cell phones and internet applications using Wireless Emergency Alerts, and to radio and television via the Emergency Alert System.
