MEETING TOPIC DETAILS

The Pennsylvania State Police, Bureau of Criminal Investigation, established the Pennsylvania Criminal Intelligence Center (PaCIC) July of 2003 in an effort to provide law enforcement agencies throughout the Commonwealth with one central point of contact for their information needs. Through the PaCIC, trained analysts provide state police members and federal. state, and municipal law enforcement officers with access to intelligence information, investigative data, and public source information 24 hours a day, seven days per week. Analysts also provide investigative support by analyzing complex information and collating it into intelligence summaries, organization charts, link analysis, time event analysis, and other manageable, professional products. The PaCIC is an attempt to provide law enforcement officers a central point of contact for information needed during traffic stops, investigative detentions, and other law enforcement encounters and investigations.

SCHOOL BUS SAFETY

How can parents and students Be Ready?



- Stay away from traffic while you are waiting for the bus.
- Always walk at least 10 feet in front of the bus when crossing so the bus driver can see you.
- Wait until the school bus has stopped all traffic before stepping out onto the road.
- · Never cross the street behind the school bus.

😥 During

- When the school bus is moving, always stay in your seat and sit facing forward.
- Keep school bus aisles open. If there is an emergency, listen to the driver and follow instructions.
- Always obey your school bus driver's instructions.
- · Never play with emergency exits.

PENALTIES

More than 700 Pennsylvania drivers are convicted for passing a stopped school bus with its red lights flashing every year.

If you are convicted of violating Pennsylvania's School Bus Stopping Law, you will receive all of the following penalties:

- 60-Day Driver's License Suspension
- Five (5) points on your driving record
- \$250 Fine





Be Informed, Be Prepared, Be Involved





On Saturday 06/05/2021, over 150 runners participated in the World's End Ultra-Marathon, which includes both 100K and 50K trail runs. The race is held at Worlds End State Park, Forksville, Sullivan County. On the weekend of 08/14-15/2021, over 150 runners traveled to Little Pine State Park in the Pine Creek Valley for the Eastern States 100, a 100 mile trail run. 25-40 amateur radio operators provided communications between 11 (Worlds End) & 16 (Eastern States) aid stations and the command posts. Radio communications included reporting bib numbers of participants as they passed through each check point, relaying aid station supply needs as well as relaying medical personnel assistance requests should a participant be injured.

Both races utilize Amateur Radio for Communications under the direction of Communications Director Travis Best – W3TMB.

5 Cyber Safety Tips

Keep your personal stuff private including the names of your family members, school, telephone number, and address. Turn off your GPS location services and your device's camera when not using them.

BLOCK IT



Be careful who you friend online. Just because someone with mutual friends wants to add you on a website or app, does not mean they are trustworthy.



CHECK IT

Think twice before you post or say anything online.

Only do or say things online that you would do or say in real life; once it is in cyberspace, it is out there forever.

FLAG IT



If you see something inappropriate, tell an adult you trust. Do not stand for bullying — online or off.



LOCK IT

Use strong passwords with eight characters or more that also has numbers, letters, AND symbols. Use privacy settings on social networking sites.

Phishing

Phishing is a form of social engineering that uses email or malicious websites to solicit personal information or to get you to download malicious software by posing as a trustworthy entity.

Types of Phishing

- Spearphishing: Phishing targeted at an individual by including key information about them
- Whaling: Phishing targeted at a high-profile individual to steal sensitive and high-value information
- Vishing: Phishing via voice communication to entice the victim to engage in conversation and build trust
- Smishing: Phishing via text messages to get the victim to click on a link, download files and applications, or begin a conversation

Protecting Infrastructure

- Secure user accounts on high-value services: Require strong passwords using a password manager and multi-factor authentication (MFA).
- Transition on-premises email servers to a cloud-based email server: Add advanced protection services (e.g., Microsoft Enhanced Account Protection and Google Advanced Protection service).
- Segment your email server from other critical assets: If your server is infected it won't harm other systems.
- Conduct Phishing Campaign Assessment (PCA): Determine the susceptibility of personnel to phishing attacks.



Signs of Phishing

- Suspicious sender's address that may imitate a legitimate business
- Generic greetings and signature and a lack of contact information in the signature block
- Spoofed hyperlinks and websites that do not match the text when hovering over them
- Misspelling, poor grammar or sentence structure, and inconsistent formatting
- Suspicious attachments or requests to download and open an attachment

Text-to-911

Text-to-9-1-1 is a service that allows the public to send a text message to 9-1-1.

This feature should only be used if it is absolutely necessary and a voice call can not be made.

Just as in a voice call, the 9-1-1 Telecommunicator will continue to ask more questions about your emergency – confirming your location, the people involved, and any other details that are important to responders.

Typing questions and answers back and forth with a 9-1-1 Telecommunicator takes a considerable amount of time, so please be patient and be as clear and concise as possible with your answers. For this reason, a voice call is preferred.

Text-to-9-1-1 may be most helpful in these emergency situations:

- By individuals who have speech or hearing impairments, or who are having a medical emergency that renders them incapable of speech;
- Instances when making noise may endanger the caller, such as a home invasion/robbery, or instances of domestic violence or an abduction.


Text-to-9-1-1 is an important tool to enhance communications with the public in an emergency, but it has many limitations. It's important to keep these things in mind:

- A text or data plan is required to place a text to 9-1-1.
- Text-to-9-1-1 conversations cannot include more than one person. Do not send your emergency text to anyone other than 9-1-1.
- Do not use abbreviations or emojis.
- Voice calls are real-time communication, Text-to-9-1-1 is not. As with all text messages, text messages to 9-1-1 may take longer to receive, may get out of order, or may not be received at all.
- 9-1-1 call takers will not be able to hear any background noise that could help them assist you during the emergency. Location information will be limited to the cell tower that your cell phone is communicating through. A 9-1-1 Telecommunicator won't automatically know where you are.

How to Send a 9-1-1 Text Message:

- Step 1: Create a new text message or conversation
- Step 2: Type 9-1-1 in the "To" or "Recipient" field (no dashes)
- Step 3: State your location: Include the address and municipality (township or borough), if you have no address provide the nearest intersection
- Step 4: Describe the situation: Include what type of emergency help is needed
- Step 5: Send the text message
