#### ACCESSING YOUR COMPLIANCE HISTORY ON LINE AT DEP'S WEBSITE

One of the most common reasons that Waste Transportation Authorization Renewal Applications are returned has to do with the Compliance History questions. These questions are referred to as Sections E1, E2 and E3 on the renewal application.

The Department of Environmental Protection has a way to check compliance history issues over the internet. It's called <u>eFACTS</u>. This is a very useful tool to use prior to sending in applications for the Waste Transportation Authorization annual renewal. Not only can it save time and money by preventing applications from being returned, but there are legal implications of submitting an incomplete and inaccurate compliance history.

#### Locating Your Compliance History

1. Log on to <u>eFACTS</u> at <u>http://www.dep.state.pa.us/efacts</u>

2. Read and click on Click here to acknowledge the above statement and continue to eFACTS Web **3.** Locate your Client information by clicking on the <u>authorizations</u> link on the "Welcome to eFACTS screen.

**4.** Type your Waste Hauler ID in the "Permit Number" box. *Be sure to include the "WH" in front of your number.* 

**5.** Click the "search" button at the bottom of the screen.

6. Click on the Client: <u>NAME</u> link.

7. All Compliance History information will be located at <u>View</u> <u>Client Inspections</u> under "Client Details" on the right side of the screen.

**8.** If there are any actions, they will be found under the red <u>Violation</u> links.

**9.** A screen describing the violation will open. The Violation Id, date, description, type, Code violated and other pertinent information will be on the screen.
