6.0 COMMISSIONER COMMENT

Mr. Metzger commented on the extremely cold weather, reminding everyone to bring pets inside and to check on your neighbors to make sure their furnaces are working, especially if they are elderly. He also mentioned participating in various community activities, including the Dream Walk in honor of Martin Luther King Day.

Mr. Mussina recommended watching the movie *Selma* and mentioned that he learned a lot about the movement from it. He shared details about the "I Have a

Dream" speech, noting that it is the most famous speeches by Martin Luther King Jr. and was ad-libbed.

Mr. Mussina spoke highly of our Former Controller Krista Rogers and expressed how fortunate we are to have Nicki Gottschall as our new controller moving forward.

Mr. Metzger commented that public service isn't easy, and Krista has dedicated herself to it for two decades, which is a testament to her commitment to the county. He thanked her personally for her service.

7.0 GENERAL PUBLIC COMMENT

Speakers who wish to address the Board of Commissioners will be limited for <u>no more than three (3) minutes</u> on any particular item. The speaker must state his/her name and address for the record. Any deviation from this rule must be approved by the Board Chairman.

Jerry Walls spoke on behalf of the Lycoming County retirees, who are seeking limited support to allow volunteer leaders to receive updates from County Commissioners. He expressed that the presence of County Commissioners who brief retirees on relevant topics is greatly appreciated. He added that previously, retiree dues were used to fund activities and donate to local nonprofits, but this is no longer affordable. Members pay \$10 annual dues, and each retiree covers their own lunch. The request is for the County Commissioners and County Controller to approve the expenses for preparing and mailing meeting notes and any related fees if the lunch venue charges a fee. He asked to please contact Mr. Walls or one of the committee members if there is a need to discuss this further.

Mr. Metzger asked Mr. Walls if they could create a yearly planner and collaborate on finding other solutions to cut costs.

Larry Stout of Montgomery emphasized the significance of Dr. Martin Luther King Jr.'s "I Have A Dream" speech. He shared the history of the speech and explained how he has used it countless times as the ultimate example of public speaking during his travels.
