7.0 COMMISSIONER COMMENT

Mr. Sortman stated that we are aggressively looking at cost savings to try to limit any increases in taxes.

Mr. Metzger stated that this year's budget has been the most difficult compared to past years, and will continue to do our best and exercise due diligence to balance the budget in the most efficient way.

Mr. Mussina reminded the community that statistically, Halloween is when children are most likely to be hit by cars. He asked for drivers to be hyper-vigilant and extremely careful, especially in highly populated areas where trick-or-treaters may be in dark costumes and not easily visible at night.

Chris Tsai, Reentry Coalition Committee, expressed she was unaware that these organizations engaged in charitable work and believes they should make this information more public so that non-profit agencies providing charitable services to the community can receive more frequent public recognition. Ms. Tsai also appreciated Commissioner Mussina's comments, finding it encouraging and reassuring to hear that all of the Commissioners are working together across party lines to help residents in Lycoming County.

Jeff Stroehmann, a county resident, stated that he appreciates everything that the Commissioners do and that true leadership comes from the bottom.
