Mr. Metzger expressed his gratitude for the crucial role the Department of Corrections plays in our society; the goal is to guide and assist individuals to make great decisions so that one day they become our neighbors and as productive as we are. ### 10.0 COMMISSIONER COMMENT

Mr. Metzger addressed that residents have left to other counties due to the shortage of homes on the market and this ripple effect affects us all; with the grant program for infrastructure, we now have the possibility of approximately 400 new homes in the market. Mr. Metzger clarified that by increasing our population, we increase the tax base and lower cost over-all.

Mr. Sortman clarified that the grants that apply to the housing initiative, originally organized by the previous Commissioners, is for infrastructure for Market Value Housing, not Low-Income Housing. Mr. Sortman stated that the developer ultimately has the last say on the type of homes; 2 of the projects are for homes to be valued between \$300-\$400k.

Mr. Mussina reminded the community of the "Back Yard Brawl" in Bowman field, this weekend. Mr. Mussina expressed that it's special to the kids to play in the same park where Major League Players do; one of the many events that makes Lycoming County special.

### 11.0 GENERAL PUBLIC COMMENT

Speakers who wish to address the Board of Commissioners will be limited for <u>no more than three (3) minutes</u> on any particular item. The speaker must state his/her name and address for the record. Any deviation from this rule must be approved by the Board Chairman.

John Shireman, Lycoming County, raised concerns regarding the delays in the Lawshee Run Project, causing the taxpayers to absorb that expense.

Mr. Shireman directed his comment to Mr. Sortman and expressed concern for the lack of employment in the area, the number of new restaurants paying lower wages, leaves those new \$300k homes out of reach for seniors and parents working two jobs to support their children.

Mr. Sortman explained the reason the comment was made is due to the negative response regarding affordable and moderate housing; we need our neighbors to not be offended by affordable and low-income housing.

Mr. Mussina shared that the new inventory in housing will allow families that are financially prepared to upgrade to the new homes; in theory this will free up more affordable homes in the market.

Tom Adams, Williamsport, Read Proverbs 22:5, shared history on William Penn's persecution and the Conventicle Act. He asked about the average time of the inmate's sentence in our county prison and if it any way incentivizes' them if they know they won't serve a long sentence. Mr. Adams directed his question to Mr. Lehman regarding the process on how mail ballots and addresses are safeguarded.

Mr. Lehman shared the organized process which involves a series of steps verified against the original voter registration, the barcode along with the details all match the registration when they vote by mail prior to election day.




### Warden Brad Shoemaker's Comments




# **Spongy Moth Feeding**









Extensive feeding by June (2007) "Winter in June"











## Spongy Moth Egg Mass Surveys

Guide to Spongy Moth Egg Mass Surveying (psu.edu)



- From the "center" tree you choose, you should search for and count all visible egg masses within a circular plot with a radius of 18.6 feet. This plot size is 1/40 of an acre.
- 12.5 egg masses per 1/40 acre x 40 =
   500 egg masses per acre.










### Spongy Moth Egg Mass Surveys



- · Egg mass surveys take place August/Sept
- 250-500 egg masses is the minimum threshold for suppression activity
- Current years egg masses are a darker tan color and firm to the touch

### Spongy Moth Spray Blocks



- Spray blocks are initially drawn in October and finalized in December
- All blocks go through an environmental review process
- Funding secure and bid for a contractor is selected by October

## **Guide to Conducting a Spray Program**

## Purpose/Objective:

- The spongy moth has been a destructive forest and tree pest in Pennsylvania since 1932. Infestations are cyclic and regional, so different portions of the state may be affected during each cycle. Counties, municipalities and landowner/homeowner associations have the option of organizing suppression programs aimed at protecting their trees and minimizing nuisance.

## **Guide to Conducting a Spray Program**

- The following guidelines are intended to provide a framework for conducting efficient and effective aerial spray programs, while also minimizing misuse of insecticides.
- To help facilitate a program, a project coordinator should first be designated. The coordinator assists in assessing the need for treatment, implements an application and collection of funds process, and acts as a liaison between property owners and the spray contractor.

## **Guide to Conducting a Spray Program**

### Purpose/Objective:

- The spongy moth has been a destructive forest and tree pest in Pennsylvania since 1932. Infestations are cyclic and regional, so different portions of the state may be affected during each cycle. Counties, municipalities and landowner/homeowner associations have the option of organizing suppression programs aimed at protecting their trees and minimizing nuisance.

## **Assessing the Need For Treatment**

Does the property contain species favored by spongy moth? The following is a listing of common tree species arranged by spongy moth feeding preference:

Favored / High: Fed upon by all size larvae – alder, apple, aspen, basswood, beech, birches (gray, white, and river), boxelder, hawthorn, larch, oaks (all species), willows, and witch-hazel.

Favored / Moderate: Fed upon by only large larvae – chestnut, eastern hemlock, and all species of pine and spruce.

Favored / Low: Only fed upon by large larvae when preferred foliage is not available – birches (black and yellow), butternut, cherry, cottonwood, elms, black gum, hackberry, hickories, hornbeam, maples, pear, sassafras, sweetgum, and walnut.

Unfavored: Rarely fed upon – ashes (all species), catalpa, dogwood, American holly, honey locust, horsechestnut, juniper, locust, striped maple, mulberry, persimmon, eastern red cedar, sycamore, and tulip poplar.

## **Assessing the Need For Treatment**

Confirm spongy moth identification, do not build tents

Do egg mass levels warrant a treatment program?

It is very important that the estimate of egg mass densities be based upon new, current-year egg masses only.

Experience has shown that 250 healthy spongy moth egg masses per acre is the threshold at which noticeable defoliation begins to appear.

Consideration should be given that larvae blow-in may occur in surrounding areas downwind of heavily infested areas.

## **Hiring a Licensed Aerial Applicator**

An aerial applicator can help you to determine what is best for each situation by: assessing the need for treatment, selecting the right insecticide, timing and project planning, and determining the area to be treated.

Important considerations before hiring a contractor include:

- Their proximity to the area(s) considered for treatment (this can impact cost).
- Availability
- Minimum acreage requirement
- Insecticide options: *Bacillus thuringiensis* subspecies *kurstaki* (Foray 48B or Foray 76B); and tebufenozide (Mimic 2LV) are most commonly used
- Cost comparisons

A list of Aerial Applicators licensed to work in Pennsylvania is provided on the DCNR website

Make arrangements with an aerial applicator in the early fall – by September 30

## **Timeline – Things to Do**

- Appoint a Project Coordinator for your Community/Town/County
- Determine area and number of acres to be treated make a map
- Conduct an egg mass survey August to September
- Inform community of survey results and potential need for spraying determine if you have any objectors
- Secure funding
- Contact multiple applicators to get quotes fixed-wing aircraft (\$), helicopter (\$\$), drone, arborist; Mimic 2LV (\$), Foray 48B (\$\$), or Foray 76B (\$\$\$)
- · Have aerial applicator selected by October 1
- · Keep community informed of approaching spraying
- Provide aerial applicator times for school buses
- Spraying is done in May when caterpillars are first or second instars and oak foliage is at least 25% of full size
