Chris Branton, Susquehanna Valley CASA Comments

Hi, my name is Chris Branton and I am currently the treasurer of Susquehanna Valley CASA. CASA stands for Court Appointed Special Advocate. We serve abused and neglected children in Lycoming County. As opposed to other organizations such as CYSA ad GAL, CASA's work with only one case at a time, and get to know the child and their needs on a more basic level. We then advise the courts through written reports and advocate on behalf of the children. CASA is a national and state level program but it is administered on a county basis. We currently serve over 20 children that are dependents of the state. We currently have 17 volunteers in Lycoming county. We also have 3 full time staff that recruit and train volunteers, work with the courts and CYS, and manage the volunteers that have active cases.

Last fall we approached the commissioners with a dilemma that was created by the budget impasse in Harrisburg. A large part of our funding comes from state funding, and it was unclear when that money would be released. The commissioners at the time provided a bridge loan to CASA in the amount of #30,000. This was approximately 1 ½ months of operating expenses. While we never had to tap into that money, there were a few times over the course of the year that were very close, and knowing that the loan was available allowed the CASA board, our employees, and our volunteers to sleep better at night.

I have the loan repayment check here, and on behalf of the board and the children we serve, I want to thank the Commissioners for their support of Susquehanna Valley CASA.
