5.0 COMMISSIONER COMMENT

6.0 GENERAL PUBLIC COMMENT

John Shire, Jersey Shore, shared his concerns for the ADA upgrades necessary specifically for the voting polls to prevent physical barriers stopping anyone from voting such as accessing doors and parking. He also asked for an update regarding the Lawshee Run Project.

Mr. Metzger responded that he can follow up in a future meeting to update the status of the project.

Mr. Shire stated that the people of the county are entitled to have an update on the mall, even if it's speculative. He expressed his concerns with the terrible conditions of the paving specifically when going into Sam's club. Lastly, he asked that the Commissioners to set an example from the top regarding the positions that were eliminated in the county to save money, he mentioned the raises they received in 2023-24 be an example of practicing what they preached.

Mr. Metzger responded that no one has been laid off, the decisions to eliminate the positions were made because the departments felt they could continue efficiently without them in place.

Mr. Shire shared a memoir of his time training in Virginia for the Vietnam War and when Apollo 11 landed on the moon which is one of the greatest accomplishments of our time. Thanks to President Kennedy instituting the space program we have the technology in electronics we have today.

Sheriff Lusk asked the public to beware of phone scammers and to avoid being victimized, hang up on anyone stating they owe money to the Lycoming county Sheriff's Office; the Sheriff's department will not call you, they will show up at your door if you are wanted.

Larry Stahl, Montgomery, shared an inspiring memoir of traveling and sharing baseball while doing missionary work and how the magic of baseball brings people together; we take for granted that we live in heart of baseball.
