

Whereas, September has been designated National Suicide Prevention Month, a month to remember the lives lost to suicide, the millions of people who have struggled with suicidal ideation and acknowledge the individuals, families and communities that have been impacted; and

PROCLAMATION

Whereas, Suicide is among the top 10 leading causes of death in the United States, resulting in about one death every 11 minutes. In addition, suicide attempts result in an even larger number of nonfatal, intentional self-harm injuries; and

Whereas, According to the American Foundation for Suicide Prevention, suicide is the second leading cause of death for people 10 to 34 years of age, the fourth leading cause of death among people 35 to 54 years of age and the eighth-leading cause among people 55 to 64 years of age; and

Whereas, Despite the positive efforts suicide remains a public health issue that touches the lives of our communities causing serious emotional, physical, and economic impacts; and

Whereas, Suicide Prevention Month is a time in which mental health advocates, individuals, prevention organizations, survivors, allies, and communities around the country unite to promote suicide prevention awareness; and

Whereas, The National Alliance of Northcentral PA (NCPA) hosts the Suicide Prevention Committee which aims to improve wellness within Lycoming and Clinton County through collaborative efforts surrounding suicide reduction, learn warning signs, promoting prevention and resilience, offering outreach, providing education, and encouraging community change and is supported by individuals who have struggled or lost loved ones to mental illness, local service agencies, providers, educators, county officials, and community partners; and

Whereas, Lycoming County strives to continue to support expansion of mental health resources and service, offer expanding crisis intervention services, and Provide Crisis Intervention Training (CIT) to firsthand responders, and training; and

Whereas, All citizens are urged to play a role in suicide prevention and promote mental health and wellness as we strive towards reducing suicides and destigmatize it through education, advocacy, outreach, intervention, and promoting the wellness within our community.

Now, Therefore, be it resolved that we, the Lycoming County Commissioners, do hereby proclaim the month of September 2024, as National Suicide Prevention and Action Month in Lycoming County, Pennsylvania.
