6.0 COMMISSIONER COMMENT

Mr. Sortman addressed recent misinformation on social media, clarifying that the county has two teams reviewing the landfill's financials. He emphasized the importance of moving the county forward and expressed concern over blaming the Commissioners for the landfill's financial losses. He highlighted that there are many unknowns regarding the history of this issue, but the current situation is that the

landfill is unprofitable and is costing more to operate than it has in the past.

Mr. Mussina echoed Mr. Sortman's statement, emphasizing that their focus should be on finding solutions rather than assigning blame.

Mr. Metzger added that it is not the Commissioners' role to micromanage departments. He stressed that individuals are entrusted to manage departments and that issues are addressed when they are brought to their attention.
