Commissioners expressed their positive partnership with SEDA COG and acknowledged Jamie Shrawder's contributions, emphasizing SEDA COG's beneficial role not only for Lycoming County but also for other regions.

Jamie Shrawder highlighted her ongoing collaboration with Lycoming County, introduced a new employee, Larissa, and noted SEDA COG's regional work with 11 counties in Pennsylvania and three outside the region (Fulton, Potter, and Sullivan) on CBDT initiatives.

He mentioned the recent appointment of new leadership, including Controller Nicki Gottshall and Director of Management & Operations, who are reviewing financial processes.

7.0 COMMISSIONER COMMENT

Commissioner Sortman reiterated the importance of adhering to proper procedures for vendor and contractor payments to prevent unreviewed expenses from impacting the budget. He highlighted efforts by Director Shannon Barnes in identifying inappropriate invoices and emphasized the need for due diligence to maintain fiscal stability. He assured that the current administration is making difficult, but necessary decisions to secure the county's financial health, appreciating staff efforts and emphasizing the importance of responsible spending.

Commissioner Metzger concurred, emphasizing that department heads bear responsibility for verifying the legitimacy of contracts before seeking approval from the Commissioners.

Commissioner Mussina acknowledged the stressful nature of the recent week due to various seasonal activities, including Little League, back-to-school preparations, and sports seasons. He shared personal updates about his family's transition to an empty nest and extended good wishes to students, parents, and athletes, urging everyone to show patience and understanding during this busy time.
