COURSE OFFERINGS 16 HOUR CLASSES SATURDAY AND SUNDAY MARCH 15—16, 2025

PUMP OPERATIONS I (PUOP)

FSC 420.001

PREREQUISITES: IST OR INTRODUCTION TO THE FIRE SERVICE AND 18 YEARS OF AGE FIRST DAY OF CLASS

This course provides the fire fighter with an introduction to basic pump construction and theory as well as operating techniques. Emphasis is placed on getting water to the pump, getting water from the pump to hose lines, and prevention of common mistakes in pump operations.

GEAR: TURN OUT GEAR

PUMP OPERATIONS II (PUOA)

FSC 421.001

PREREQUISITES: PUOP AND MUST BE 18 YEARS OF AGE FIRST DAY OF CLASS

This course is designed to instruct the student in advanced techniques of operating pumps. Topics covered include friction loss, relay pumping, master streams and elevated master streams.

GEAR: TURN OUT GEAR

FORCIBLE ENTRY (TFE)

FSC 700.001

PREREQUISITES: ESSENTIALS OF FIRE FIGHTING or EXTERIOR FIRE FIGHTER.

MUST BE 18 YEARS OF AGE.

GEAR: TURN OUT GEAR, GOGGLES OR SAFETY GLASSES (HELMET FACE SHIELDS ARE NOT SUFFICIENT EYE PROTECTION!)

This course will provide the fire fighter with a better understanding of building construction. Also covered are opening techniques and the use of tools for safe and quick access into a structure.

ENGINE COMPANY OPERATIONS (ECOP)

FSC 205.001

PREREQUISITES: EBM OR INTERIOR FIRE FIGHTING OR FF-1 CERT.

MUST BE 18 YEARS OF AGE.

GEAR: TURN OUT GEAR, SCBA

This course provides instruction in the duties and responsibilities of an engine company. Topics include: fire behavior and spread in structures, positioning of apparatus, use of attack and backup lines, search and rescue, and water supply. A series of hands-on drills involving various engine company evolutions follows the classroom discussion.

ROPE/HIGH ANGLE RESCUE II (RORA)

FSC 339.001

PREREQUISITES: 16 YOA BY THE FIRST DAY OF CLASS

GEAR: HELMET WITH CHIN STRAP (fire, construction or climbing helmet), EYE PROTECTION (safety glasses or goggles), CLEAN LEATHER GLOVES, WORK OR HIKING BOOTS, OUTDOOR WORK CLOTHING OR COVERALLS AND A CLASS III HARNESS.

FIRE FIGHTER TURNOUT GEAR IS NOT APPROPRIATE FOR THIS CLASS. (Helmet face shields are not suitable eye protection)

STUDENTS WILL ALSO NEED A 15 FOOT SECTION OF ROPE AND A 15 FOOT PIECE OF TUBULAR WEBBING FOR KNOT PRACTICE.

Students in this course will be re-introduced to the various types of rescue equipment. Students will be trained in; mechanical advantage systems, safeties, basic ascending, basic rappelling technique and tie-offs with a rappel rack, rope changes, and one person rescue. The students will perform a low angle raise and lower evolution simulating patient transport on embankments. Most of the program is hands-on and time is allotted for practice in order to build proficiency.

TRUCK COMPANY OPERATIONS I (TRCO)

FSC 209.001

PREREQUISITES: EBM OR EQUIVILANT / TRUCK 1

MUST BE 18 YEARS OF AGE.

GEAR: TURN OUT GEAR, SCBA

The student will be introduced to the basic concept of truck company operations as part of an organized, coordinated structural fire suppression operation. Truck companies, regardless of whether they arrive on an aerial device, squad, or engine, are the 'combat engineers' of fire attack operations. This course, for experienced fire fighters, will introduce the student to the basic concept of truck company operations and duties, including organizing the delivery of truck company services, selection and use of key tools, advanced ventilation and forcible entry theory and practices, search and rescue, and other fire attack support functions.

BASIC FIRE POLICE (BFPO)

FSC 0604.001 MUST BE 18 YEARS OF AGE OR OLDER

GEAR: NONE

This course was designed to prepare persons selected to be fire police officers to know the initial legal requirements and to understand how to perform the basic duties of the position. This course sets for the NEED for fire police; their legal police power; personal and professional qualifications; their appointment and control; their general and special duties; and their limitations.

INTRO TO FIREOFFICERSHIP (INFO)

FSC 0226.001 MUST BE 18 YEARS OF AGE OR OLDER

GEAR: NONE

This course will give those students wishing to become Fire Officers, the ability to function safely and effectively as a management component of a fire/rescue organization. Effective management skills and styles will be covered as well as effective communications, progressive discipline, philosophy of management, organizational skills, and Company Officer strategy and tactical considerations.

INTRODUCTION TO THE FIRE SERVICE (ELIS)

FSC 3459.001 / 3459.002

PREREQUISITES: MUST BE 14 YEARS OF AGE BY FIRST DAY OF CLASS

GEAR: TURN OUT GEAR

This entry level course is designed to introduce new firefighters to basic information including an overview of the fire service, fire service organization, firefighter safety, personal protective equipment, tools and emergency lighting, and backing apparatus. This is the first of five levels (courses) in the curriculum

SATURDAY MORNING CLASSES

SOLAR PANEL AWARENESS FOR THE FIRE SERVICE

FSC 0381.001 CLASS IS ON SATURDAY AM (4 HRS)

Description: This 4 hour course is intended for Emergency Responders, as well as, other private or municipal agencies. This course is an awareness level program covering system types, code compliant installations, associated hazards, and safe work practices near solar PV systems. The course will introduce students to solar PV system operation, components, design and recommended practices.

FIRE DYNAMICS ATTIC FIRES

FSC 1060.001 CLASS IS ON SATURDAY AM (4HR CLASS)

**PREREQUISITES: 14 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE**

Building upon knowledge gained from Fire Dynamics Fundamentals and Fire Dynamics Strategy & Tactics, the student will have a better understanding of Size-Up, Command, Fire Attack, and Fire Ground Support as it pertains to Attic Fires

WATER RESCUE AWARENESS (WRFRA)

FSC 0580.001 CLASS IS ON SATURDAY AM (3HR CLASS)

**PREREQUISITES: 18 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE**

This program discusses the characteristics of water-related emergencies and the health and safety risks to First Responders. This program addresses the common hazards associated with water rescue emergencies, as well as, the First Responder's initial role, on-scene responsibilities, and Responder limitations. This course will assist to increase the First Responder's ability to maintain scene/rescuer safety and control. During this program, students are introduced to important safety procedures related to weather exposure and physiological conditions, near drowning, personal protective equipment, including PFD (Personal Floatation Devices), and initial action plan development for water rescue emergencies will also be presented in this program.

PTSD AWARENESS

FSC 0868.001 CLASS IS ON SATURDAY AM (4HR CLASS)

**PREREQUISITES: 18 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE**

This program defines PTSD, risk factors for firefighters, signs and symptoms to look out for in Fire Departments and what to do if one of your members is showing these signs. Discussion will provide students with the tools to make their Departments aware of the needs of response personnel in dealing with and discussing behavior wellness issues.

THE ART OF READING SMOKE

FSC 0989.001 CLASS IS ON SATURDAY AM (4HR CLASS)

**PREREQUISITES: 16 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE**

This program will cover this is an important skill of reading smoke since fighting fires in the year 2006 and beyond will be unlike the fires we fought in the 1900's. Composites, lightweight construction, engineered structures, and unusual fuels will cause hostile fires to burn hotter, faster, and less predictable.

SATURDAY 8 HR CLASSES

HEAVY TRUCK RESCUE (8 HR CLASS) (MAX 20 STUDENTS PER SESSION)

FSC 0622.001

PREREQUISITES: 16 YOA OR OLDER.

GEAR: TURN OUT GEAR – EYE PROTECTION – SAFETY GLASSES OR GOGGLES

This program addresses the hazards and resource demands for extrication emergencies involving large and heavy vehicles. Addressed in this program, are vehicle design considerations, weight distribution hazards, payloads, strength points, and special hazard considerations. The course teaches the student how to assess, stabilize, and access vehicles of greater size and weight. Students will learn how to address special resource needs encountered during extrication emergencies.

VEHICLE EXTRICATION STRATEGIES AND TACTICS (8 HR CLASS) (MAX 20 STUDENTS PER SESSION)

FSC 2474.001

PREREQUISITES: STUDENT MUST BE 16 YEARS OF AGE THE FIRST DAY OF CLASS.

GEAR: TURN OUT GEAR – EYE PROTECTION – SAFETY GLASSES OR GOGGLES

This course will provide an awareness level of information and skills as it pertains to vehicle rescue incidents. Topics will include general vehicle rescue function/operation; incident management of the vehicle accident/rescue incident; vehicle anatomy, design, and construction; recognition and control of hazards relative to a vehicle accident/rescue incident; and the tools and equipment used at a vehicle accident/rescue incident.

SATURDAY AFTERNOON CLASSES

**KNEE WALLS & HAZARDS OF HIDDEN FIRES
IN WOOD FRAME STRUCTURES**

FSC 1054.001 CLASS IS ON SATURDAY PM (4 HR CLASS)

**PREREQUISITES: 14 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE**

This course will use real-life examples to illustrate the threats posed by smoke explosions and extreme fire development pose by fires in knee walls concealed spaces of wood frame structures. Case studies from several Pennsylvania incident. For all levels of firefighters, from incident commanders to line firefighters and Safety Officers.

LITHIUM-ION BATTERY INCIDENTS

FSC 1053.001 CLASS IS ON SATURDAY PM (4 HR CLASS)

**PREREQUISITES: 14 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE**

Lithium-ion battery incidents have proven to be a challenge to the fire service requiring extended manpower hours and copious amounts of water to extinguish them. Most fire department actions have been a "Press Pause" for them to only reignite hours, days, or weeks later. This program will cover chemical/physical properties, terminology, causes of failure, chemical/physical hazards, recognition/identification, firefighter safety, reference resources, operation modes, extinguishing/cooling methods, secondary responder guidance, incident termination, and educational resources for responders and the community. The program will cover incidents involving electric vehicles, mobility devices, electronic devices, tools/equipment, transportation shipping, and energy storage systems.

SURFACE ICE RESCUE AWARENESS (SIRA)

FSC 0447.001 CLASS IS ON SATURDAY PM (2.5HR CLASS)

**PREREQUISITES: 18 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE**

To goal of this program is to provide the student with the initial necessary knowledge for responding to ice immersion emergencies. Surface Ice Rescue Awareness will provide the student with the knowledge to size up an ice immersion emergency, provide for rescuer safety, provide site control and scene management and determine the necessary additional resources needed to mitigate the emergency. Surface Ice Rescue Awareness will assist an organization with becoming NFPA 1670 compliant with Ice Rescue Awareness.

AUTISM AWARENESS

FSC 0388.001 CLASS IS ON SATURDAY PM (4 HR CLASS)

**PREREQUISITES: 18 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE**

About 1 in 68 children are diagnosed with an autism spectrum disorder (ASD) according to estimates from the Center for Disease Control's (CDC) Autism and Developmental Disabilities Monitoring (ADDM) Network (2014). ASDs are reported to occur in all racial, ethnic, and socioeconomic groups. Children with ASD are 7 times more likely to have the need for emergency services and firefighters need to be aware of their special needs.

COURSE OFFERINGS SUNDAY MARCH 16, 2025

SUNDAY MORNING CLASSES

CLANDESTINE DRUG LABS AWARENESS

FSC 827.001 CLASS IS ON SUNDAY AM (3HR CLASS)
PREREQUISITES: 18 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE

This program is designed to provide First Responders with the basic recognition and identification skills for clandestine laboratories and the dangers associated with the chemicals used to manufacture illegal drugs. The topics of discussion will include personnel safety when operating at these locations, hazardous materials and wastes produced and required interaction with law enforcement. Participants must be current members of a recognized First Response agency.

ALTERNATIVE ENERGY VEHICLES

FSC 602.001 CLASS IS ON SUNDAY AM (4HR CLASS)
PREREQUISITES: 14 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE

This program contains information on recent vehicle safety technology upgrades, which may pose concerns with extrication efforts. This course covers basic vehicle safety and technology changes. Safety features such as: air bag systems, seat belt systems, fuel system changes, safe work zones, vehicle construction materials, and passenger compartment upgrades. Changes to size-up, extrication techniques, and resource needs will also be presented in this program.

EFFECTIVE BUDGETING FOR FIRE OFFICIALS

FSC 1068.001 CLASS IS ON SUNDAY AM (4HR CLASS)
PREREQUISITES: 18 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE

This program is designed to develop an awareness of budgetary responsibilities and practices for the new or aspiring fire officer. This program will discuss numerous factors and considerations in preparing and preparing a successful and well accepted fire department budget to elected officials and the general public. This program is used to expand upon preexisting knowledge and skills acquired by the student in previous training programs.

SUNDAY AFTERNOON CLASSES

FENTANYL AWARENESS

FSC 830.001 CLASS IS ON SUNDAY PM (3 HR CLASS)
PREREQUISITES: 18 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE

This program is designed to provide First Responders with the basic recognition and identification skills for clandestine laboratories and the dangers associated with the chemicals used to manufacture illegal drugs. The topics of discussion will include personnel safety when operating at these locations, hazardous materials and wastes produced and required interaction with law enforcement. Participants must be current members of a recognized First Response agency.

FLAMMABLE GAS REVIEW

FSC 0148.001 CLASS IS ON SUNDAY PM (3 HR CLASS)
PREREQUISITES: 18 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE

This program is designed to review the types and nature of flammable gases. This course will reinforce pre-existing knowledge and skills acquired by the student in previous training programs. Topics include: physical and chemical properties of flammable gases, suppression strategies, resources and equipment needs, and agent selection and application.

FIRE SERVICE RISK MANAGEMENT

FSC 1058.001 CLASS IS ON SUNDAY PM (4 HR CLASS)
PREREQUISITES: 18 YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE

The goal of this program is to provide emergency services leadership with an understanding of the principles and practices of risk management as it relates to public safety. Participants will examine types of risks and the three-levels of risk management: Community, Organizational, and Operational Risk Management. This program is designed to give the emergency services leader the necessary skills to understand the concept of risk and risk management. Designed to be a stand-alone course, the information presented will provide foundational knowledge for pursuing advanced fire company office certification.

SUNDAY 8 HR CLASSES

HEAVY TRUCK RESCUE (8 HR CLASS) (20 STUDENTS MAX)

FSC 0622.002 CLASS IS ON SUNDAY (8 HR CLASS)
PREREQUISITES: 16 YOA OR OLDER,
GEAR: TURN OUT GEAR

This program addresses the hazards and resource demands for extrication emergencies involving large and heavy vehicles. Addressed in this program, are vehicle design considerations, weight distribution hazards, payloads, strength points, and special hazard considerations. The course teaches the student how to assess, stabilize, and access vehicles of greater size and weight. Students will learn how to address special resource needs encountered during extrication emergencies.

VEHICLE EXTRICATION STRATEGIES AND TACTICS (20 STUDENTS MAX)

FSC 2474.002 (CLASS IS SUNDAY 8HRS)
PREREQUISITES: STUDENT MUST BE 16 YEARS OF AGE THE FIRST DAY OF CLASS.
GEAR: TURN OUT GEAR – EYE PROTECTION – SAFETY GLASSES OR GOGGLES

This course will provide an awareness level of information and skills as it pertains to vehicle rescue incidents. Topics will include general vehicle rescue function/operation; incident management of the vehicle accident/rescue incident; vehicle anatomy, design, and construction; recognition and control of hazards relative to a vehicle accident/rescue incident; and the tools and equipment used at a vehicle accident/rescue incident.

COURSE OFFERINGS

16 HOUR PROGRAMS

FLASHOVER RECOGNITION AND SURVIVAL IS A PA STATE FIRE ACADEMY ON THE ROAD PROGRAM. STUDENTS WILL EARN A CLASS CERTIFICATE FROM THE PSFA

There will be two (2) offerings for this program.

FSC 900.001 Saturday March 15, 2025

FSC 900.002 Sunday March 16, 2025

There is an additional 75.00 Lab Fee for this class that must be paid at the time of registration.

***Flashover Recognition and Survival™ (ZFRS)** – is an 8-hour course designed to give the student the practical knowledge required to recognize and understand the phenomena called “flashover”, how to identify “pre-flashover” conditions and deal with these conditions in a safe and controlled manner. The ultimate outcome is to avoid firefighters from becoming victims of this violent phenomenon. Two live fire evolutions inside the simulator are required for successful completion of this course.*

STUDENTS MUST BE 18 YOA

ON THE FIRST DAY OF CLASS

Class size is limited to 14 students

Firefighters that are going to apply for the program will need to demonstrate that they have successfully completed either the

- PA Entry Level Firefighter Training Program (ELIF) with live fire; OR
- PA Entry Level Firefighter Training Program (ELIF) with no live fire AND Structural Burn Session; OR
- Essential Basic Module (EBM) AND Structural Burn Session
- Or Firefighter I certification.

Copies of the certificate will need to be submitted with the Application.

Students will be required to have full Structural Firefighting Personal Protective Equipment (PPE) including SCBA with a spare cylinder.

STRUCTURAL BURN SESSION (SBS)

FSC 0600.001 Class is Saturday and Sunday (16 hr Class)

**PREREQUISITES: 18 YEARS OF AGE OR OLDER FIRST DAY OF CLASS, EL22 PROGRAM (ELIS/ELFG/ELEF/ELIF) OR BBFA
GEAR: FULL PPE WITH SCBA AND A SPARE CYLINDER**

This course will provide the student with a review and application of the techniques used in safe fire fighting practices in an actual fire environment. Emphasis is placed on safety for both interior and exterior operations.

L 105 PUBLIC INFORMATION OFFICER

FSC 1055.001 class is Saturday and Sunday (16 hr class)

PREREQUISITES: 18 YEARS OF AGE OR OLDER ON FIRST DAY OF CLASS

This course introduces participants to what the Public Information Officer (PIO) does in emergency management, along with basic information about the Integrated Public Alert and Warning System (IPAWS). The PIO topics covered include the role of the PIO; communication tools and resources encompassing social media; effective communication; preparing the community through outreach and other means; and communication in an incident. The IPAWS topics covered include what the system is and does, preparing alert and warning messages, and writing common alerting protocol messages. This is a three-day classroom course that gives participants time to perform activities and exercises to reinforce the knowledge and build basic skills.

BASIC RIT

FSC 760.001 Class is on Saturday and Sunday PM (16 hr Class)

**PREREQUISITES: 18YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: TURN OUT GEAR, SCBA (SPARE CYLINDER)**

This course is designed to provide firefighters with the knowledge and skill objectives to safely perform rescue techniques to remove trapped or lost firefighters during deteriorating suppression activities. This course is for firefighters who are members of a RIT, and tasked with extrication responsibilities during structure fires. Included in this course: RIT Team roles and responsibilities, evaluation of case studies, function during suppression activities, lifting and moving techniques, extrication support needs, team building skills, and size-up techniques and structure layout.

INCIDENT SAFETY OFFICER CLASS (ISO)

FSC 108.001 Class is on Saturday and Sunday PM (16 hr Class)

**PREREQUISITES: 18YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE**

The Safety Officer's responsibilities fall into two clear cut categories: those associated with responding at the incident scene, and those associated with managing the day to day affairs of the department. The Incident Safety Officer (ISO) course is focused on the incident and the role the Safety Officer plays as part of the Command Staff. The target audience is Company Officers (CO) who are experienced in firefighter safety issues and are familiar with an Incident Command System, hazardous materials management, and related emergency operations. The program provides the student with the decision-making process and skills required to recognize unsafe acts and conditions and take appropriate corrective actions.

ARSON DETECTION FOR THE FIRST RESPONDER (ADFR)

FSC 0734.001 Class is on Saturday and Sunday (16 hr Class)

**PREREQUISITES: 18YEARS OF AGE OR OLDER FIRST DAY OF CLASS
GEAR: NONE**

The course covers topics which fire suppression personnel must be familiar with in order to facilitate origin and cause determination and possible subsequent investigation of intentionally set fires. Upon successful completion the student will be able to provide a clear definition of the role of initial responder organizations and to provide essential knowledge to enable them to recognize the potential of an intentionally set fire, preserve evidence, and properly report the information to appropriate officials.

CLASSES THAT HAVE ADDITIONAL LAB FEES ASSOCIATED WITH THEM
